I heard a call go out over the radio reference a disturbance at Castle View Elementary School located at 6201 Shaker Dr. Dispatch advised that the subject had assaulted a staff member and possibly taken another one hostage. Dispatch advised that the subject had gone into a room with the hostage and barricaded himself in the classroom. I started heading that direction from the Central NPC to assist the responding units. I arrived on scene and took up a perimeter spot on the southwest corner of Century Ave./Shaker Dr. After an hour or so several officers and I were instructed to escort students from several classrooms onto waiting school busses.
