My partner Officer O'Farrell and I were conducting 290 Compliance checks in the East NPC area when we heard RPD dispatch advise that a suspect had assaulted a teacher and drug her back into a classroom. Upon hearing the call, We responded code 3 to the location and upon arrival took up tactical positions on the outside of the classroom. I remained in that location until I was relieved by Metro team members. After being relieved I assisted other RPD Officers with handing out food and water to the Metro officers and Patrol officers that were positioned on the perimeter.
