On 10-31-17 at approximately 1130 hours, I was at the old Greyhound Station located at 3911 University Ave. attending Integrating Communications, Assessments, and Tactics (ICAT) training when I heard a call broadcasted over channel one involving a possible battery/barricaded subject at Castleview Elementary School. I then heard an Officer say that there was smoke coming out of the classroom and they needed to evacuate students. I got in my city owned car (unmarked unit #349) and I drove to the location in the event it turned into a METRO Operation (I was assigned to the collateral SWAT team at the time). I parked my vehicle next to the basketball courts and I went to where the armored vehicle (ARV) was parked near a ground on the northwest corner of the school. When I arrived, I was tasked with driving the ARV to classroom "A1." I drove towards the classroom and parked the ARV approximately 15' northeast from the front door. I remained in the driver's seat the entire time and I tried to use the ARV's spotlights to obtain a view from inside the classroom but there was too much of a glare on the windows to determine for sure what
