62. Narrative of Supplemental Report 62a. Audio Recording Available? No 62b. Incident Number: On 10-31-17 at approx. 1308 hours I received a text from Sgt. Goodson advising me there was a full Metro callout at Castle View Elementary School. As part of the Metro Team I responded to the location arriving at approx. 1430 hours. I was advised that a suspect was barricaded inside classroom A1 with a hostage. I was told by Sgt. Goodson to cover the rear (southwest corner) of that building with Off. Ouk. We took cover behind a small building at that location where the restrooms are located and had a clear view of classroom A4. During the incident an OIS (officer involved shooting) occurred, but I did not witness it because of my location. I remained at the scene until I was advised clear the scene and to report to the Magnolia Station. I was advised by detectives I was to write a supplemental report in lieu of being interviewed.
