Narrative of Supplemental Report Assignment: On Tuesday, October 31, 2017 at 1112 hours, I responded to assist officers on scene at 6201 Shaker Dr. (Castle View Elementary School) located in the City and County of Riverside, CA. Dispatch advised over channel one that a suspect had barricaded himself in a classroom and possibly had a teacher held hostage. I arrived on scene at 1150 hours and made contact with Ofc. D. Cisneros in the school's main office. Once in the office, Sgt. T. Banks assigned me as the "secondary position" for Emergency Negotiations Team (ENT). Myself, along with other team members positioned ourselves in the health office and started making attempts to contact the suspect or victim inside of classroom "A1". In the secondary position, I monitored Ofc. D. Cisneros during the entire negotiation process. The majority of the time, we utilized the intercom system to classroom "A1". 3 no time did anyone answer the phone and I could hear the phone ringing in the background of the intercom phone
4 call we had on speaker phone. I continued doing this until entry was made and the situation was neutralized.

6 I was advised by ENT supervision to stand by in the ENT motorhome for a debrief. Once the debrief was over, I
