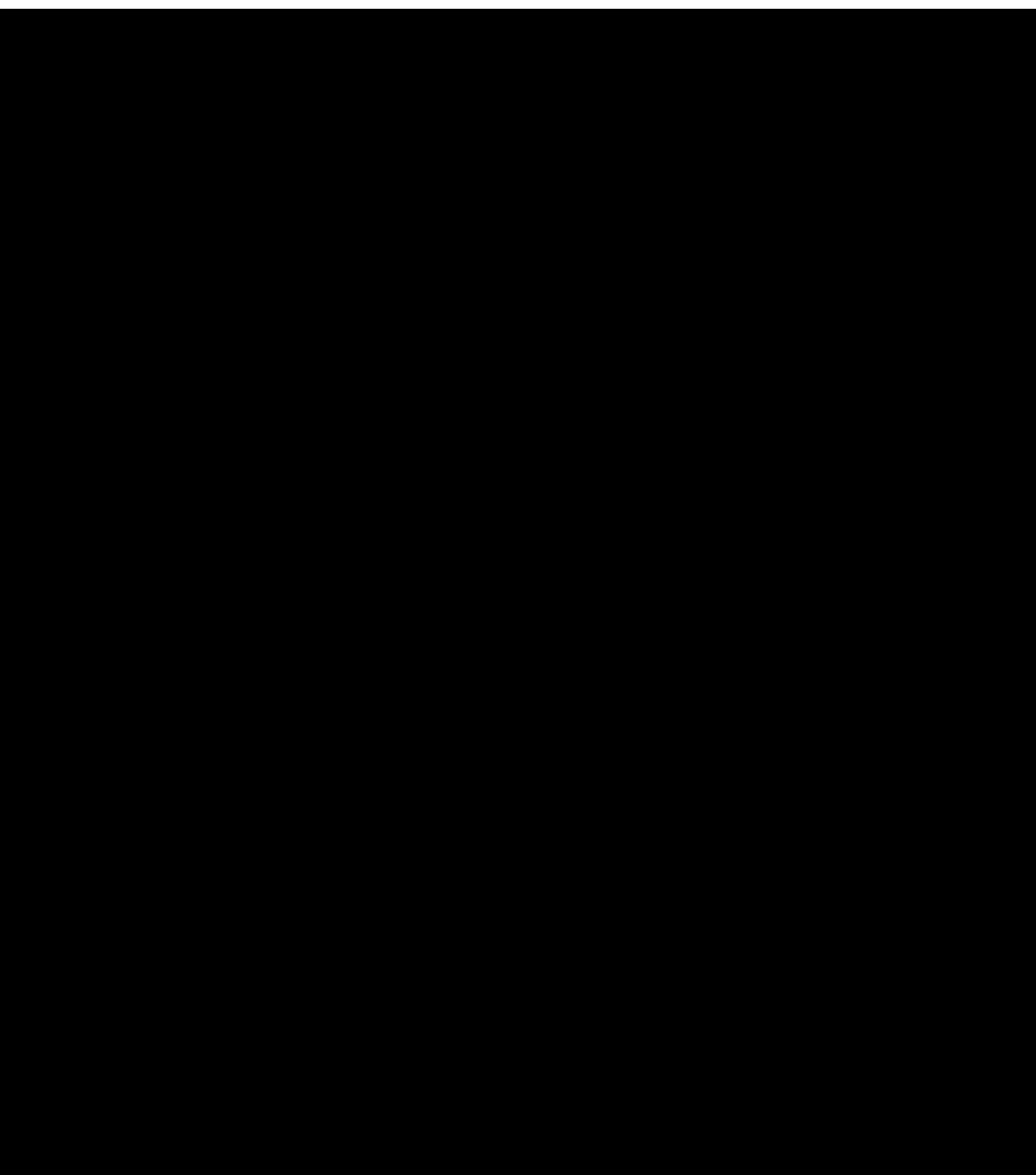

I contacted [REDACTED] by phone on 02/25/17. He told me that he let his cousin, O-2 [REDACTED] stay with him in October of last year. He said that [REDACTED] is a Heroin addict and he was trying to help him. He said [REDACTED] stole his gun and he has not seen him since that day. He thinks [REDACTED] is living somewhere in [REDACTED].

It is unknown where or when S-Garcia came into possession of the handgun.

ASSIGNMENT/ARRIVAL:

On 10/23/2013, I was assigned to work uniform patrol in the City of [REDACTED] as 19P21. I was driving a marked Sheriff's patrol unit and wearing a full Class A Sheriff's uniform.

At approximately 1232 hours, I was assigned to a theft of a gun report at the incident location.

I arrived on scene at approximately 1251 hours and made contact with the victim.

VICTIM CONTACT:

I contacted [REDACTED] at the incident location and the following is a summary of what he told me.

[REDACTED] stated his Smith & Wesson MP9 Shield was stolen out of his house. [REDACTED] stated there was no a break in at his residence that he is aware of but his gun is missing out of the nightstand in his bedroom. [REDACTED] stated he keeps his gun in the nightstand next to his bed and last saw the gun approximately three weeks ago when his cousin, [REDACTED] was at his residence. [REDACTED] stated he and [REDACTED] were inside of his room and [REDACTED] was acting nervous and trying to get out of the house. [REDACTED] left the residence shortly after and [REDACTED] has not heard from [REDACTED] since then. [REDACTED] stated he has not contacted [REDACTED] reference the gun. [REDACTED] noticed it was missing today because his friend was over and asked him what kind of gun he has, so he went to grab the gun and realized the gun was missing. [REDACTED] also stated his cousin, [REDACTED] uses drugs frequently and is addicted to drugs.

[REDACTED] stated his gun was worth approximately \$450.00. [REDACTED] stated no one had permission to take his gun out of his nightstand and nobody should be in possession of the gun.

ADDITIONAL INFORMATION:

A teletype was sent for the gun with serial #HSU5636.

The involved party's full name is [REDACTED] stated he did not see his cousin [REDACTED] take the gun from his residence and is not 100% sure if he is the one who stole the gun.
