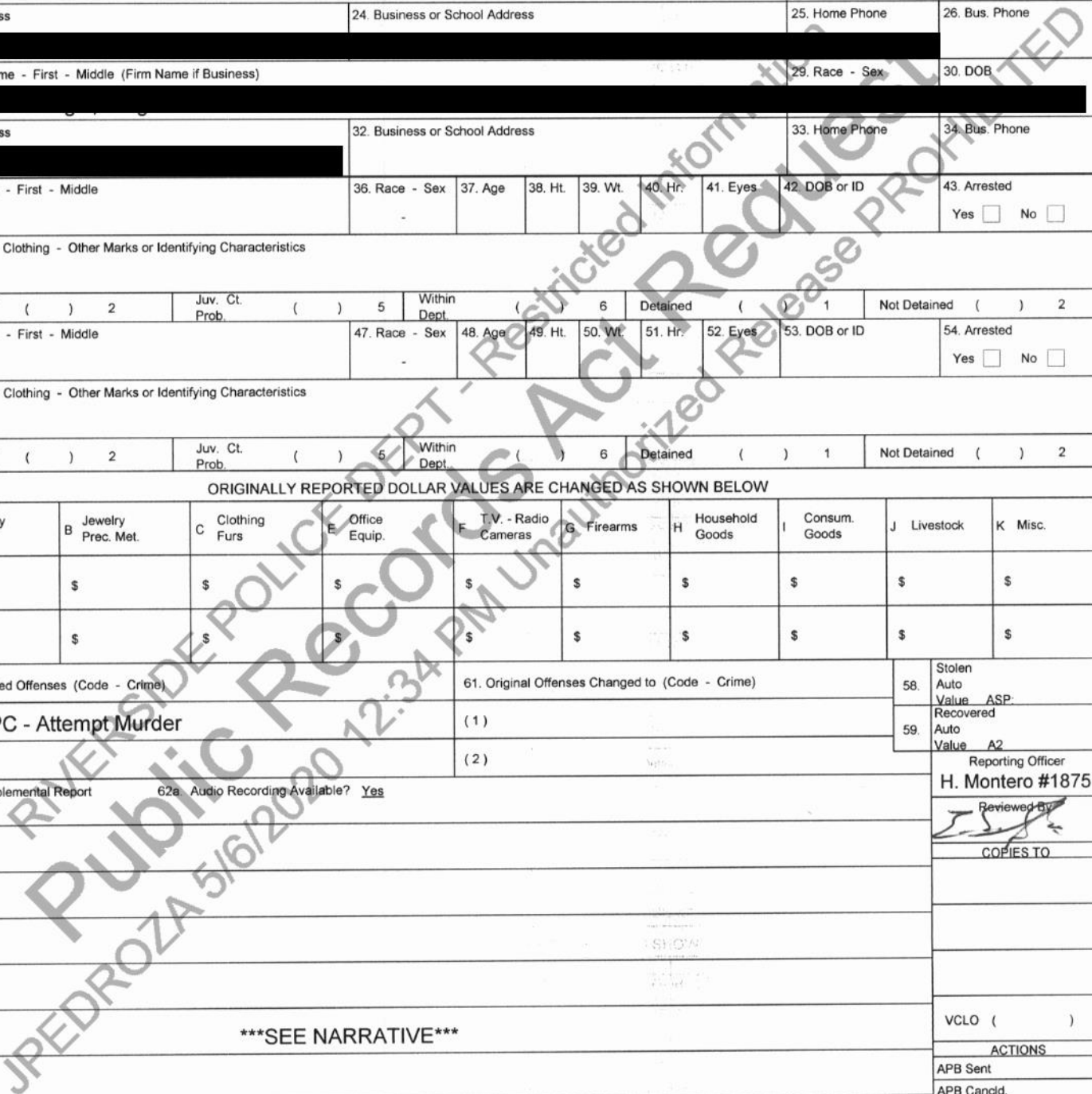

**DETAILS:**

On 07-21-2018 at about 0837 hours, I responded to assist with crime scene containment at Arlington Ave and Streeter Ave reference the Officer Involved Shooting from the previous evening. I was in full police uniform and driving a marked Riverside Police vehicle.

I arrived at the location and was instructed by Det. Corbett to release the vehicles left at the crime scene to the owners. Before releasing the vehicles to the owners Victoria Towing Company arrived at the scene and the suspect vehicle (LIC#: 7JPW282) was stored for evidence per authority code 22655.5CVC at the Magnolia Police Station. The suspect vehicle was towed at 1050 hours. The suspect vehicle was entered into SVS by Dispatch #1744 at 1055 hours.

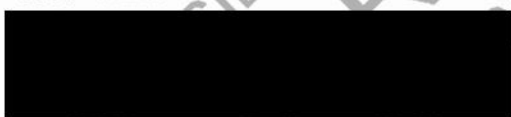

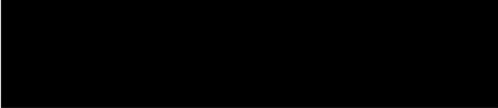
