On the above date and time, I was assigned to the North NPC and during my shift I heard our police dispatch broadcast that an outside agency was currently involved in a vehicle pursuit and it was now near by our city. Dispatch also advised the suspect was armed and had previously shot at law enforcement during the pursuit. The suspect vehicle entered our city at the 215 freeway and Van Buren Blvd. I activated my lights and sirens and drove towards that area. I exited the 91 freeway at Van Buren Blvd and caught up to the pursuit at Van Buren Blvd and Dufferin Avenue. I entered the pursuit at that location and I was approximately 10 vehicles behind the primary suspect vehicle. I continued the pursuit within the general above area as the suspect vehicle made several right and left hand turns from Victoria Avenue and its surrounding cross streets. As a result of my involvement, my patrol vehicle (No. 3510) overheated and my brakes began to smoke reaching failure. I discontinued my involvement in the pursuit and pulled over off of Victoria Avenue. I was no longer involved at that point and waited for a tow truck who transported my unit to the city yard. NFI.
