1 NARRATIVE:

2 On 07/20/18, at approximately 1934 hours, I responded to the area of Devonshire Avenue x Kirby Street, in the
3 City of Hemet, County of Riverside, to assist the Hemet PD Crime Suppression Unit (CSU) in a vehicle pursuit.
4 While responding to the area, Hemet PD Sergeant M. Mouat aired over the radio that they were in pursuit of a
5 silver Chrysler convertible (CA/ 7JPW282) , which was possibly a suspect vehicle involved in a PC 246 crime.
6 Shortly after, Sergeant M. Mouat aired that he and Detective Paez were shot at by the sole occupant and driver
7 of the suspect vehicle.
8

9 OFFICERS ACTIONS:

10 I responded code 3 (forward facing solid red light and audible siren,) in my marked black and white Hemet PD
11 K-9 Unit (#3055) to the pursuit location. As the pursuit continued west bound on Florida Avenue at a high rate
12 of speed and out of the city limits, I continued to follow its path as I attempted to catch up to the primary
13 pursuing units.
14

15 I continued traveling code 3 behind the pursuit until Riverside PD took control of the pursuit, in the City of
16 Riverside. Once Riverside PD took over the pursuit, I trailed them until the pursuit termination point. After
17 arriving at the termination point, a Riverside PD Lieutenant (unknown name) advised they had the scene under
18 control and did not need any assistance from outside agencies. I then left the scene and responded back to the
19 City of Hemet. This concludes my actions in reference to this incident.
20

21 It should be noted my department issued body worn camera (BWC) was active while responding code 3. My
22 BWC was later uploaded to the docking station inside of the evidence room at Hemet PD.
