DETAILS

This is a supplemental report to the Officer Involved Shooting that occurred in the area of 9931 Willowbrook St, Jurupa Valley, on 03/08/18.

On Friday, 03/09/18, I attended the autopsy of Ernie Saldivar at the Riverside County Coroner's Office, located at 800 S. Redlands in the city of Perris. Dr. Fajardo was the Pathologist who performed the autopsy and was assisted by Coroner Technician Zelon and Forensic Technician Almendariz. Forensic Technician Almendariz took digital photographs to document the autopsy and collected the evidence items that were given to him by Coroner Technician Zelon.

The autopsy began at approximately 0900 hours when Dr. Fajardo broke the body bag seal, Seal #093509. While in the body bag, I noticed Saldivar was handcuffed behind his back and was wearing a black shirt (RN07), white tank top undershirt (RN08), black basketball shorts (RN05), and plaid boxer shorts (RN04). Saldivar's white socks (RN01) and white shoes (RN02) had been placed between his feet prior to being transported from the scene. The black shirt (RN07) and white undershirt (RN08) appeared to have been cut along the middle by medical personnel. Saldivar was described as a male adult, 72 inches tall, weighing 184 pounds, with black hair and brown eyes.

Coroner Technician Zelon and Dr. Fajardo removed the handcuffs (RN06) from Saldivar and then removed all of his clothing items (Refer to Evidence Section above for clothing descriptions and collection times). Saldivar's body was washed and Dr. Fajardo conducted an external examination of his body. I noticed Saldivar had a gunshot wound to his left shoulder, two gunshot wounds to his chest, a gunshot wound to his left upper abdomen area, a gunshot wound to his right shoulder, a gunshot wound to his right side (lateral), a gunshot wound to his right hip area, a gunshot wound to his right forearm, a gunshot wound to his left hand, a gunshot wound to his midback, a gunshot wound to his left back, and a gunshot wound to his right back. Dr. Fajardo also noted several graze wounds to Saldivar's right upper abdomen area, right side above the hip, and right thigh.

After conducting the external examination, Dr. Fajardo examined the X-ray photographs of the body and removed a total of six projectiles: Left upper abdomen, two from the left shoulder, right lung, spinal cord, and left shoulder blade (Refer to Evidence Section above for descriptions and collection times). Evidence items RN14 and RN16 were both removed from the left shoulder blade and appeared to be related. Dr. Fajardo stated it was possible the jacketing (RN14) was from the lead projectile (RN16) based on the fact they were both found in the same area and had the same trajectory.

29 Dr. Fajardo advised me Saldivar had injuries to both his lungs, heart, and liver, and would not have
30 survived his injuries. Dr. Fajardo stated he could not provide trajectories at this time and wanted to
31 review his notes and photos before making those determinations.

1 The autopsy concluded at 1155 hours. The Cause of Death will be pending Coroner
2 Review. I collected the evidence items from Forensic Technician Almendariz and transported them
3 to the Lake Elsinore Sheriff's Station where I logged/secured them into the evidence locker
4 (Evidence items RN04, RN07, and RN08 were placed in the Air Dry Locker).
