62. Narrative of Supplemental Report On 10-31-08, I responded to 7800 Cypress Ave. reference a 5150 call. Upon arrival, I saw Officer Koehler and Ratkovich in the middle of the street trying to control a male subject. Both officers were using their body weight and were kneeling on top of his back. The male subject was lying on his stomach. I immediately assisted them by holding his legs down with both of my hands on his calves. As I was holding his legs down, I could feel him trying to move his legs in order to get free. Officer Koehler then asked me to retrieve a hobble as the male subject was still being uncooperative and continued to resist arrest by moving around. Upon my return, Officer Heiting who had arrived to the scene, had already retrieved a hobble and assisted Officer Koehler and Ratkovich with the arrest. I then proceeded to provide crowd control and stopped all W/B traffic from the east side. I also started a Major Incident Log and maintained it throughout the incident.
