Narrative of Supplemental Report:

On 10/31/08, I received a phone request from Sergeant M. Rossi to process the scene of an Officer Involved Fatal Incident. At 2347 hours, I arrived at the 7800 block of Cypress Avenue and contacted Detective Rick Cobb. I received an incident brief from Sergeant B. Blomdahl. I processed the scene and took victim photographs at the direction of Det. Cobb. On 11/13/08, I completed a digital video recording of the scene, Evidence Item #CM7. I took digital photographs of the scene, vehicles and evidence items collected. At 0133 hours, I left the scene and reported to Parkview Community Hospital (3865 Jackson Street). I contacted Deputy Coroner B. Clark and Det. Cobb in Emergency Room #3. I took digital photographs of the suspect: Marlon Acevedo. At 0219 hours, I cleared Parkview Community Hospital and reported to the scene on the 7800 block of Cypress Avenue, at 0223 hours. I took additional vehicle photographs. I measured and collected (6) items, Evidence Items #CM1-CM6, assisted by Det. Cobb. I completed a rough sketch of the scene. Refer to the Scene Diagram, Vehicle Diagram, Photo Logs and Evidence Logs. At 0259 hours, I cleared the scene and transported the evidence items to the Magnolia Station.

At the Magnolia Station, I took digital photographs of Evidence Items #CM1, CM2, CM5, CM6, JH1, JH2, DK1, DK2, JR1 and JR2. I took digital photographs of Officers J. Heiting and J. Ratkovich, and Officer D. Koehler, his glasses and his injuries. At the direction of Detective G. Rowe, I did not photograph the Taser belonging to Officer Ratkovich or the gun belt. I reproduced a CD copy of Item #CM7, I labeled the copy Evidence Item #CM7-A. I took a total of (231) digital photographs of the scene, evidence items, suspect and Officers. I downloaded the photographs to
