62. Narrative of Supplemental Report On 022513 2050 hours I monitored a "GTA in progress" call at the Peppertree Apartments. I arrived simultaneously with Officer Disla and parked in the front parking area facing west just east of the west gate. Officer Disla contacted the reporting party west of my unit (3921). I saw the reporting party yell and point to the gate and say "There he is, that's him". I saw Officer Disla run to the gate and yell for someone to stop and surrender. He announced over the radio that he was in foot pursuit. Believing the suspect was on foot, I entered the interior of the apartment complex and parrelled Officer Disla. Later I saw Disla toward the rear and ask him where the suspect was, he replied that the suspect was in a vehicle and other officers were chasing him toward the front. We ran back toward the front. As we reached the first building from the parking area I heard 10-12 shots being fired. I entered the front parking area and saw that the suspect vehicle was facing west with the front of the car nearly touching Unit 3912 (Officer Oakes and Wilder's car) I saw that the suspect was still in the vehicle and had been shot. the other officers could not see the suspect's right hand. In that hand I could see an unknown object wrapped in black electrical tape. I told the officers that it was either a knife or a butt of a gun. The suspect appeared to be unconscious and fearing he would regain consciousness and either try to accelerate or use the object in his right hand, I opted to enter the passenger side door and secure the object. I removed it from his hand and found that it was a "shaved key" with a handle wrapped in electrical tape. I set this object on the right front passenger seat. I saw that the vehicle's automatic gear selector was in the "drive" position and that the engine was still running. I placed the gear selector as far forward as I could and turned another "shave key" that was in the ignition until the engine shut off. I also removed a black bag or back pack from the right floor board to get it out of the reach of the suspect and set this bag onto the ground.

The officers then removed the suspect from the vehicle and I checked for an "ETA" of medical aid. Along with Sergeant Tipe and Toussaint, involved officers were separated and taken to Magnolia Station. Notifications were made and the scene was contained. I remained at the scene until relieved by the Robbery/Homicide Officer Involved Shooting Team.
