Incident Number: P12030492 On 03-01-12 at approximately 0226 hours I heard an Officer advised that he was in foot pursuit south bound Anna. Moments later I heard an Officer advised 11-99 shots fired. Partner Officer B. Porter #1710 and I responded to the area from Alessandro Blvd. and San Gorgonio. Upon arrival, we initially parked at the entrance to the gated community at Hyde Park Cir. and Lincoln Ave. Officer Porter than parked our marked patrol unit to the front of 5996 Maybrook Cir., blocking all east/west traffic on Maybrook Cir. I then contacted the resident at [Redacted] O1/ McAlpine, Glenda). I asked her if everyone inside the residence was okay and she stated yes and that she lives alone. I then maintained an outer perimeter position at Hyde Park Cir. and Lincoln Ave., until relieved by Sgt. Lambert at 0530 hours. Sgt. Lambert then had us secure the perimeter to the front of 2942 Anna, north of Lincoln Ave. We stayed on scene until relieved from the scene by Sgt. Russell at 0932 hours.
