Incident Number: P12030492 On 03-01-12, at about 0226 hours, I responded to the area of Anna/ Lincoln reference a request for emergency assistance for an officer that had just been involved in a shooting. Upon my arrival, I found that the officers that where involved were safe and located on Anna north of Lincoln. At this time I retrieved crime scene tape, and secured Anna Street by taping it off north of Lincoln Street. After the entire scene had been secured, I began to canvas the scene in an attempt to locate possible witnesses. I first responded to the residence located at [Redacted] I spoke with the residence at this location, who was identified as Martin Deliyski. He explained the following: W/Deliyski said that he was sleeping in his bed when he was awakened by three gunshots. After the gunshots he heard someone yelling, but could not heard what they were saying. He then heard an additional two gunshots. W/Deliyski said that he did not go outside to see what was happening, and could not provide any further details about what he heard.	Reporting Officer C. Narrative: (Continued)

I then responded to [REDACTED]. I contacted a female subject, who was identified as Katie Griggs. She explained the following: W2/Griggs said that she was awake at the time of the incident, and was laying in her bed. As she was laying in bed she heard to gunshots coming from outside. These two gunshots where followed by someone repeatedly yelling to "Get Down", and then an additional two gunshots. She later looked out her front window to see what was happening, but only saw a lot of police cars and police officer running around.

I then spoke with W2/Griggs husband, who was identified ass Kevin Griggs. He explained the following: W3/Kevin said that he was sleeping when his wife woke him up. After his wife woke him up, he heard someone yelling outside, and then he heard two gunshots. He later checked outside, but only saw a lot of police vehicles and police officers.

I responded to [REDACTED]. At this location I spoke with a female subject, who was identified as Esther Lee. She explained the following: W4/Lee said that she has been asleep all night long, and that she did not hear or see anything.

I then responded to [REDACTED]. At this location I spoke with a female subject, who was identified as Marge Fittante. She explained the following: W5/Fittante said that she was sleeping when she woke up to the sound of many police sirens outside. W5/Fittante said that as she was hearing the sirens, she heard two loud popping sounds. She could not clarify as to whether or not these popping sounds were gunshots or not, nor could she confirm at what point she heard the possible gunshots in relation to the sirens that she heard.
