Narrative of Supplemental Report:

On Tuesday December 31, 2013 I was assigned as a dayshift patrol supervisor working uniformed patrol. At 1133 hours I monitored a radio broadcast of an Officer Involved Shooting that occurred at Arlington Park. I responded Code-3 with lights and siren from 6585 Norwood. I arrived on scene and immediately ensured the involved officers were safe.

I obtained a Public Safety Statement from Officer P. Miranda and provided that information to the Watch Commander and Robbery/Homicide investigators when they arrived. Officer Miranda told me that he and his partner officer Asbury contacted the suspect in the park and the suspect produced a handgun and fired it towards them. Miranda believed that he fired his duty handgun at the suspect five times. Officer Miranda said his handgun was pointed in a western direction. Officer Miranda said he was not hit or struck by the suspect's gunfire. Officer Miranda told me that there were no other or outstanding suspects. Detective Melendrez accompanied Officer Miranda to the Magnolia Station until relieved by Homicide Investigators.

I coordinated scene management with Sergeant McCarthy which included a perimeter around the park and Command Post at Van Buren Blvd. and Miller. I remained on-scene until I was relieved by Homicide Unit Supervision.
