W/Cynthia Ledezma stated she had been inside the front house, when she heard her aunt (O/Rebecca Ledezma) and uncle (S/David Ledezma) outside arguing, because of marital problems. She then heard what																																				
sounded like gunshots. When she ran outside she saw several police officers and S/David Ledezma outside.																																				
W/Cynthia Ledezma stated O/Rebecca and S/David are both "alcoholics" and there is a history of domestic violence between them.
