**On 01/07/12, I was working uniformed patrol in the City and County of Riverside. At about 1620 hours I heard a request for assistance from Officers broadcast over the police radio. I responded to their location at 10745 Cypress Ave. Upon My arrival, the scene was already secure, but I observed several people standing to the front of the residence. I contacted a female who identified herself to me as, Rebecca Ledezma(W). She told me she had been involved in a verbal and physical argument with her husband, S/David Ledezma, and had asked her nieces to call the police. She told me she was told by the initial arriving Officers to wait to the front of the residence until they were done contacting S/David Ledezma. She told me she did not witness the OIS but she heard the gunshots (refer to COBAN video and audio recording for a more detailed statement). I transported V/Ledezma to the Magnolia Police Station to be interviewed by the detectives. NFI.**
