Narrative of Supplemental Report:

On 01-07-12 at approximately 1623 hours I responded to the listed location from the Lincoln Street Police Station reference a radio dispatch of an 11-11 shots fired. Upon arriving at the location I observed several officers securing the crime scene and marking evidence.

I contacted Sergeant Banks and advised I would coordinate the process of having the involved officers and witnesses transported to the Magnolia Street Police Station. I designated officers to transport the three involved officers separately to the station. I also had several witnesses transported to the station by assisting officers. Sergeant Hardin responded to the Magnolia Police Station to coordinate the follow-up investigation.

I then designated several officers to conduct a neighborhood canvas for additional witnesses. After coordinating the transportation of the involved officers and witnesses and coordination the neighborhood canvas I cleared the scene.
