62. Narrative of Supplemental Report

On 01/07/12 at approximately 1614 hours I was working uniformed patrol in a marked police unit, as a Patrol Sergeant. At about that time I heard a patrol unit request help reference shots fired. I responded to their location and arrived on scene at approximately 1634 hours. After arriving on scene I stood with the three involved officers and the police explorer until we could make separate arrangements for their transportation to Magnolia Station. At about 1715 hours I transported Explorer Martinez to the Magnolia Police Station and met with the other three officers in the Conference Room on the first floor. While in the Conference Room, Detective Tpire ordered the officers and the explorer not to discuss the incident while they waited for the Detectives to arrive. I stayed with the officer's and the explorer until their Peer Counselor's arrived and each involved party was assigned a counselor. I cleared the Station at about 1801 hours.
