**Injuries:**

According to Riverside Community Hospital RN Lindsay Bacca, S/Ledezma had three gunshot wounds. One of the wounds was in the "Trans-abdominal" area, which was on the left side of S/Ledezma's chest. One of the wounds was on S/Ledezma's left leg above his knee. The third wound was on S/Ledezma's right leg above his knee. S/Ledezma ultimately succumbed from his injuries and was pronounced deceased by RCH Dr. Peter Wawro at approximately 1814 hours.

**Narrative:**

On 01-07-12 at approximately 1625 hours I began responding to 10745 Cypress Ave., regarding an officer-involved shooting. The officers on-scene were requesting additional units. I activated my emergency lights and sirens and arrived at that location at approximately 1629 hours. I initially assisted officers on-scene with a security sweep of the premises. Afterward, I was directed by Sgt. Banks to ride along with S/Ledezma in MR Unit #331. [S/Ledezma was transported to Riverside Community Hospital (RCH) for treatment of gunshot wounds. See initial report and other supplemental reports for details.] While riding in the ambulance with S/Ledezma and the medical staff I activated my PUMA digital recorder. We arrived at RCH at approximately 1655 hours without incident.

Upon arrival at RCH, S/Ledezma was rushed into the emergency room where he was being prepared for the operating room. S/Ledezma was then transported to Operating Room #6 where he received further medical assistance. I was ultimately advised by RN. Bacca that S/Ledezma had succumbed to his injuries. He was pronounced deceased by Dr. Peter Wawro at approximately 1814 hours.

RPD Forensics Detective Ellis responded to RCH for photographs. (See his supplemental report for further information.) Deputy Coroner Mendoza then responded to RCH where she took custody of S/Ledezma and his personal belongings. Deputy Coroner Mendoza provided me with their department case number: #201200233. Assisting officers and I maintained security at the hospital until we were eventually cleared by supervision. I then responded back to the residence at 10745 Cypress Ave. and assisted with scene preservation until I was cleared at approximately 0110 hours on 01-08-12.
