Narrative

On 01-07-12 at approximately 1700 hrs I was called out to 10745 Cypress for an Officer Involved Shooting (OIS) by the on-call Sgt, Sgt Lisa Williams.

I arrived at about 1800 hrs. I attended a briefing at the scene and was then assigned to assist with witness interviews at the Magnolia Police Station.

I responded to the Station and interviewed W-Cynthia Ledezma, who told me she was S-David Ledezma's niece (her father Edward is S-Ledezma's brother). W-Cynthia Ledezma had been transported to the Magnolia Police facility by uniformed officers. I spoke to her alone in an interview room. The following is a summary of her statement, which was recorded:

Cynthia Ledezma's Statement

W-Cynthia told me that she has been living at the house on Cypress since Thanksgiving. The home belongs to her grandparents, Maria and Jose Ledezma. W-Cynthia said her father Edward also lives there but he was at work when the incident occurred. Her Aunt Rebecca and Uncle David live at the house as well.

W-Cynthia told me that at about 2:00 PM this afternoon O1 Rebecca and S-David left the house in their car to go to a benefit carwash for someone they knew. Sometime in the late afternoon they returned. W-Cynthia was in the house doing her hair when she heard O1 Rebecca out in the front yard saying, "What happened to you, what happened to you?" W-Cynthia said she went out to the front door, stood in the doorway (West side of the house) and saw her Aunt being consoled by her cousins, O2 Yvette Ledezma and O3 Yvonne Ledezma. W-Cynthia said she was about 8 to 10 feet away from them and heard what was going on. Her Aunt was telling her cousins that S-David had been hitting her, pulling her hair and "driving all crazy" while they were driving home. She also said he had her money. O1 Rebecca told them that she was tired of it and she was going to call the police. W-Cynthia said she could see her Uncle over by the car. The trunk lid was open and he was throwing things around from the trunk of the vehicle. W-Cynthia said she heard her cousin Yvette call the police, so she went back inside the house.

W-Cynthia said her Aunt and Uncle arguing is common. They were always drinking, and she figured they probably had been drinking this afternoon as well, but she didn't know for sure though because she didn't get close enough to either one of them after they got home.

W-Cynthia said she was in the house for a while (she is not sure for how long) in the bathroom on the north side of the house when she heard someone outside yelling, "No dad no. Stop." W-Cynthia said she went to the front door and as she came outside she heard 5 to 10 gunshots.

She saw three uniformed police officers in dark police uniforms with their pistols out and they were pointing and shooting them at S-David, who was now on the ground near the front of his car. There was another police employee there (unarmed) in a light blue shirt (Police Explorer ride along). She could hear the officers yelling, "Drop the weapon", or something like that, but she said she didn't see anything in S-David's hands. The officers stopped shooting as W-Cynthia ran over towards them and she got to within 8 feet or so when they told everyone to stay back. Her Grandmother came running out of the house to see what was going on after the shooting, but she was not out there when it happened. Her Grandfather came out after that.

W-Cynthia Ledezma said she did not see when the officers arrived and she did not see what happened between the officers and her Uncle prior to the shooting. W-Cynthia said that she did not hear the officers or her Uncle yelling anything while she was in the house.

W-Cynthia said she had nothing else to add, and was given a ride back to her residence by uniformed officers. The recording of this interview was downloaded to the RPD server.
