Interview of [REDACTED]

On 1/16/12, I interviewed W-[REDACTED] by phone. He was previously interviewed by Officer Mendonca the night of the shooting, but the interview was not recorded. I recorded this interview with my digital recorder and later downloaded it to the department server.

W-[REDACTED] said that he was walking down the alley that separates [REDACTED] where the shooting occurred. He said he saw the cops at the rear of the next door residence with their guns out. He said he heard the cops tell S-Ledezma to drop whatever was in his hand. He said he did not see what was in S-Ledezma's hand. I asked him if he saw a knife in S-Ledezma's hand and he said he did not know if it was a knife or not.

W-[REDACTED] said a cop then fired his taser at S-Ledezma. He said S-Ledezma went to the ground, where he grabbed a pole. He said he "tossed" the pole "a little" hard at the cops. He said he does not know if the pole hit the cops, but he saw it bounce off the ground. He said the cops then shot S-Ledezma more than 6 or 7 times.

W-[REDACTED] said he did not know if the pole was metal or plastic. He said it was thin. I asked W-[REDACTED] if he remembered telling the Officer who interviewed him that night that S-Ledezma picked up a metal pipe. He said he did not tell the officer it was a metal pipe.

I asked W-[REDACTED] if he told the Officer who interviewed him that night he saw S-Ledezma holding a knife. He said he did not know if it was a knife or not.

W-[REDACTED] had no further information.
