1 **Narrative:**

2 On 01-07-12 at about 1625 hours, I heard partner Officers Putnam and Espinoza  
3 broadcast via radio that shots were fired and they request urgent back up. Responding from  
4 downtown Riverside, I responded to their dispatched location at 10745 Cypress Av, Riverside  
5 CA, 92505. Upon arrival, I saw multiple bystanders standing around on the street outside.

6 I made contact with W/[REDACTED] who stated she lived at the listed address.  
7 Following is a summary of the statement provided by W/[REDACTED]

8 On 01-07-12 at about 1600 hours, W/[REDACTED] said [REDACTED] (Maria Luisa  
9 Ledezma), was having a verbal argument with [REDACTED] (David Ledezma), in regards to  
10 him cheating on her. W/[REDACTED] said David Ledezma had a knife in his hand during the  
11 argument. W/[REDACTED] said David Ledezma was in the backyard when police arrived. W/[REDACTED]  
12 said police officers approached David Ledezma and pointed tazers at him. W/[REDACTED] said she  
13 was standing by the front door of her residence at this time. W/[REDACTED] said she heard the police  
14 officers yelling at David Ledezma to put the knife down. W/[REDACTED] said she heard a few  
15 popping sounds and then what she thought was the sound of the electrical current running on the  
16 tazer. W/[REDACTED] said she then went out to the street with her other siblings.

17 I went to [REDACTED] where I made contact with W/Guerrero, Maria (20yrs).  
18 Following is a summary of the statement made by W/Guerrero:

19 W/Guerrero said she was inside her residence when she heard approximately seven (7)  
20 gunshots. W/Guerrero said another family member looked outside and told her that the police  
21 were there. W/Guerrero came outside to see what was happening where she stayed until she  
22 was contacted by police.

23 I cleared the scene and returned to my patrol area.
