Narrative of Supplemental Report:

On the listed date and time, I responded as the uniformed field supervisor to the above location to assist the PACT team with a vehicle pursuit. While enroute to the scene, officers advised they were in a foot pursuit and then an officer involved shooting occurred. I arrived on scene and began directing officers to set up containment of the scene. There were two separate crime scenes involved inside of the contained area, so I directed officers to take up positions to secure those scenes and directed Officer Delarosa to handle the 5431 Bushnell address and Officer Bartlone to handle the 10479 Keller address for crime scene log purposes. The command post was set up on Keller west of Jones and Officer Waters was assigned to the Command Post for the outer perimeter crime scene log.

Medical aid had already been requested for the suspect who was pronounced deceased in the rear yard of 10471 Keller which backs up to the original address listed. Arriving officers were assigned to contact and interview any witnesses they could locate and were directed to write supplemental reports of their statements.

Members of the Riverside Police Departments Persons Unit, Forensics Unit and Internal Affairs Unit responded to the scene. Members of the Riverside County District Attorney's office and the Coroners office responded. Lt. Toussaint relieved me as the incident supervisor at 1645 hours.
