On 05-10-11, at approximately 1757 hours, I was working as field supervisor in the east area of the city. While working I heard a radio call of shots fired at 11532 Trailway, dispatch also advised that at least two people were down. I began to respond to the call, while responding I heard officers on scene advise that shots had been fired.

I arrived at the scene shortly after the broadcast. When I arrived, Sgt. Corbett and Sgt. Banks had a group of officers setting up a perimeter on the residence at 11532 Trailway. I was advised that we possibly had additional suspects at 11531 Trailway. As Officers were starting to set a perimeter around the 11531 residence I saw a male suspect, who had a gunshot wound, lying face down in front of the house. The suspect appeared to be breathing. I had Officer Munoz and Officer Roy pull the suspect to a place of safety where he could receive medical aid. Once we had a complete containment set and Sgt. Corbett's team had cleared 11532 Trailway, I had dispatch call into the residents at 11531Trailway and have them step out of the house. Once the five occupants were secured form the residence Metro officers conducted a safety sweep of the house.

Once the scene was secured I assisted Sgt. Corbett establish a crime scene. Once the CIB detectives were briefed and took over the crime scene I cleared at 2117 hours.
