3 O1/Green stated the following:

4 O2/Villegrena and O3/Del Cid were at his residence (11524 Trailway Drive) in the back yard
5 helping him build a Gazebo. At approx. 1700-1730 hours, he heard some people in the back
6 yard of 11532 Trailway Drive (his female neighbor's residence, victim-1). It sounded and
7 smelled as if she were having a BBQ. At approx. 1800 hours, he heard people screaming (both
8 male and female). He heard at least 30 gun shots, during this time (the majority of the shots
9 sounded as if they came from the rear yard of 11532 Trailway Drive). Both he and the workers
10 sought cover in his rear yard, until the police arrived. He stated the he knew both the female
11 victim and the male suspect and that the male seemed very different after the two split up. He
12 stated the suspect moved in to the neighbor's residence across the street (11531 Trailway Drive).

14 O2/Villegrena stated the following:

15 Both he and O3 were hired to work in O1's back yard, while working in the rear yard (at 11524
16 Trailway) at approx. 1800 hours, he heard people screaming (both male and female). He heard
17 at least 30 gun shots, during this time. The majority of the shots sounded as if they came from
18 the rear yard of 11532 Trailway Drive. Both he and the others sought cover in the rear yard,
19 until the police arrived.

21 O3/Del Cid stated the following:

22 Both he and O2 were hired to work in O1's back yard, while working in the rear yard (at 11524
23 Trailway) at approx. 1800 hours, he heard people screaming (both male and female). He heard
24 at least 30 gun shots, during this time. The majority of the shots sounded as if they came from
25 the rear yard of 11532 Trailway Drive. Both he and the others sought cover in the rear yard,
26 until the police arrived.
