19 **Assignment:**
20 On May 10, 2011 at 1800 hrs, I was contacted by Det. Cobb regarding a shooting call in the west area of
21 Riverside. He told me there had been several "shots fired" calls received by RPD dispatch and multiple
22 victims shot, as well as, an officer involved shooting. I responded to the scene at the Palisades Estates to
23 meet with Sgt. Hudson and members of the Robbery/Homicide Unit. The scene had been cordoned off
24 with crime scene tape, marked patrol units and uniformed officers. I attended an incident briefing given
25 by Sgt. Corbett where he stated officers were called to 11532 Trailway Dr. Riverside, CA reference
26 shots being fired. Ofc. Fishell arrived in the area and saw a black male suspect (S/Virgil Millon)
27 standing over a female (V/Arabella Bradford) who was on the ground. Ofc. Fishell watched as the
28 suspect fired two rounds at the female. Ofc Fishell fired multiple times at the suspect striking him and
29 causing him to fall to the ground. Officers found the female and a second victim (V/Malvin Conley)
30 lying to the front of the residence with multiple gunshot wounds. RFD personnel checked both victims
31 and declared them deceased. The suspect was taken by ambulance to Riverside Community Hospital
32 where he was later pronounced deceased. RPD officers secured the scene and Ofc. Fishell was taken to
33 CIB for an interview.

34
35 After the briefing, I, Det. Cobb, Det. Brandt, Det. Simons, Sgt. Hudson, Sgt. Capen and Sgt. Corbett did
36 a walk-thru of the scene. Sgt. Corbett pointed out various items of evidence officers had discovered, as
37 well as, where the suspect had been at the time he was shot by Ofc. Fishell. Det. Brandt and Det.
38 Simons stayed behind to process the scene with ID technicians while Det. Cobb and I returned to CIB to
39 interview witnesses and Ofc. Fishell.

41 At CIB, I interviewed V/Arabella's mother, W/Luigina Barkley. This interview was audio recorded.
42 What follows is a synopsis of that interview.

1 W/Luigina Barkley:

2 Luigina lives in Lakewood, CA and was in Riverside to visit her daughter, Arabella, over the Mother's
3 Day holiday weekend. Several other members of the family were at Arabella's home over the weekend
4 but only a few remained on Tuesday the 10th. On the morning of the 10th, Arabella left for work and all
5 seemed to be fine with her. To Luigina's knowledge, Arabella had not had any recent problems with her
6 ex-boyfriend, Virgil, who lives across the street from her on Trailway Dr. Arabella returned home
7 around 1600 hrs and she was in good spirits. Arabella, Luigina and Marilisa (Luigina's other adult
8 daughter) went to Marshall's to do some shopping. They returned to the home at 11532 Trailway Dr. to
9 have a BBQ. While they were out, Arabella spoke with a person she was seeing named Malvin. She
10 asked Malvin to come over and join them for the night. Malvin agreed to come over and was going to
11 bring his friend, Marvin. The two men were already at the house when the three women returned home.

12
13 The entire group went inside to prepare dinner. Malvin and Marvin went outside to the backyard to
14 prepare the BBQ while the three women were inside. A pool repair man (W/Clint Garcia) was also in
15 the backyard working on Arabella's pool equipment at the time. While in the kitchen of Arabella's
16 home, Luigina saw Virgil appear in the backyard out of nowhere. Arabella asked Virgil what he was
17 doing at her house. He came into the house through the back sliding door and grabbed Arabella by the
18 hair. He began dragging her out of the house through the open slider and into the backyard. Luigina
19 could see Virgil was holding a handgun as he dragged Arabella outside. Luigina tried to pull Arabella
20 back toward the house by grabbing her foot but Virgil knocked her down and continued to pull Arabella
21 deeper into the yard. Seconds later, Luigina heard gunshots. She saw Virgil fire one bullet into the air
22 and then he began to fire at Arabella as he held her by the hair. Luigina was very scared and tried to get
23 out of the line of fire. She watched as Virgil fired his gun until it was empty and then switched to a
24 different gun. The second gun Virgil pulled from his clothing and began firing it at Arabella. As she
25 tried to hide, Luigina watched Virgil drag Arabella back into the house by pushing through the window
26 of the sliding glass door. Virgil dragged Arabella into the kitchen then through the house toward the
27 front door. Luigina could hear Virgil firing his gun as he moved through the house. The last thing
28 Luigina saw was Virgil dragging Arabella out of the front door and into the front yard. Luigina did not
29 see what happened to the front of the house.

30
31 Minutes later, police officers arrived at the house and called them to exit the residence. She and
32 Marilisa were taken to the police station for questioning.

33
34 Luigina described the relationship between Arabella and Virgil as mostly good. They had been dating
35 for around 8 years and lived together at 11532 Trailway Dr. They did not have any children in common.
36 Virgil had at least one child from a previous marriage. Their relationship ended badly around 1 ½ years
37 ago. Sometime after their break up, Virgil moved into the 11531 Trailway Dr. where he has been living
38 ever since. Arabella and Virgil have been involved in a lawsuit over their home and other issues. Virgil
39 was arrested by the police a few years ago (RPD File #P08021063 - 245(a)(2) PC). Arabella currently
40 works as a parole officer while Virgil had been fired from his job in law enforcement.

1 Approximately 8-9 months ago, Arabella told Luigina about an incident where Virgil had threatened
2 both her and Malvin while they were out jogging. The couple was near her home when Virgil
3 approached them both and said, "Bitch, I'll cut you!"

4
5 There was also an incident in April where Arabella found out that Virgil had completed a change of
6 address form with the post office to have all of her mail and some of Luigina's mail re-routed to a P.O.
7 Box belonging to Virgil. This meant checks intended for Arabella never made it to her. Arabella filed a
8 police report on this activity (RPD File #P11058672 – Suspicious Circs) outlining what had happened.

9
10 Other than the listed incidents, Luigina did not know if there were any other problems between Arabella
11 and Virgil. Arabella remained mostly quiet about Virgil. Luigina felt this was her way of keeping her
12 from worrying. 3-4 weeks ago, Arabella began the restraining order process against Virgil. Luigina had
13 heard that Virgil was served with court paperwork on Monday the 9th. To her knowledge, Virgil did
14 nothing after receiving the paperwork. Due to the problems she was having with Virgil, Arabella began
15 carrying a gun in her car wherever she went. Arabella was very afraid of Virgil but would not back
16 down in a confrontation with him.

18 After I ended my interview with Luigina, she and her family were taken to a local hotel while RPD
19 officers processed Arabella's home and the surrounding area.
