**Narrative:**

On 11-16-11 I responded to an Officer Involved shooting at the above location. Upon arriving on scene I armed myself with my AR-15 assault rifle and took up a position across a small parking lot at the 3-4 corner of the suspects' apartment. I held that position until Metro officers arrived and set up in the complex closer to the suspects' apartment. After being relieved I cleared the scene.

At approximately 1030 hrs I was assigned to return to location to canvas the apartment complex for any witnesses to the shooting. Detective Arnold and I were assigned building #M.

I first contacted O/McClenaghan. O/McClenaghan said that he was in the apartment, house sitting for a friend. He said that sometime in the early morning he heard 5 gunshots, then one gunshot and then 3-5 rapid gunshots and then one more gunshot. He said that he then heard sirens and saw police officers in the complex. We then showed him a California Department of Motor Vehicle photo print-out for S/Romo and his wife Margie Valentine Romo [REDACTED] (Margie). He said he did not know either individual.

O/Clomera advised that at about 0737 hrs she was in her apartment when she heard 9-12 "bangs" she felt were gunshots. She said she heard 2-3 gunshots and then a pause and then more gunshots. She said she knew it was 0737 hrs because she looked at her clock at the time she heard the shots. She said she then heard the helicopter a short time later. We then showed her the California Department of Motor Vehicle photo print-outs for S/Romo and his wife Margie Valentine Romo [REDACTED] (Margie). She said that she knows Margie from seeing her in the complex. She said that she sometimes talks to Margie when Margie waters her plants. She said

that she has seen no problems with Margie. She said that she knows S/Romo and Margie are Husband and wife. She said that S/Romo is not friendly and never speaks to anyone.

We then showed her a California Department of Motor Vehicle photo print-out for S/Romo and his wife Margie Valentine Romo [REDACTED]. She said she did not know either one.

O/Prout said at about 0700 hrs she and O/DiVincenzo left the complex to go workout. She said they returned at about 1130 hrs and observed the police activity at the complex. They did not see or hear anything. We then showed her a California Department of Motor Vehicle photo print-out for S/Romo and his wife Margie Valentine Romo [REDACTED]. She said that S/Romo looked familiar but she has had no contact with him.
