W/Steppe, in Apt told me the following:
She lives alone, but had a gentleman friend over last night (identified by her as Robert "Bob" Raven, from
Apt per his business card given to me by W/Steppe) that had left prior to our
arrival. She saw policemen and a police dog go by her apartment earlier, so knew of their presence. Her
friend "Bob" saw a neighbor, known as "Gloria" (see Det. R. Ryder's supp rpt. ref. W/Engebretson) walking
outside, and invited her to join them inside her apartment. She didn't know why police were in the complex,
but Gloria was telling them about it. Det. Ryder showed W/Steppe pictures of S1/Romo and his wife.
W/Steppe said she recognized them as the ones with the "nice plants". W/Steppe knew which apartment
they lived in, because they have a lot of nice plants around it, and described the location of the apartment
(she described #242). She had seen them (S1 and wife) a few times before. She saw them having BBQs
near her apartment, and saw the wife in the laundry room, but did not know them personally. She didn't see
the husband (S1/Romo) attend the BBQs lately. She believed they had an adult daughter that sometimes
visited them, but didn't really know anything else about them. They appeared happy when she observed
them. W/Steppe has lived in the complex for six (6) years, in June. She did not know about the incident,
and did not hear or see anything in its regard.
