Narrative of Supplemental Report:
 On 10/18/2012, I received a phone request from Detective Rick Cobb to transport evidence to the Riverside Department of Justice (DOJ) for analysis. On 10/19/12, at 1112 hours, I checked out Item #SL14: "(1) Black magazine w/ (15) WINCHESTER 40 S&W cartridges-walkway of S/E of APT #55", from Magnolia Station Police Property Specialist R. Anzelde. I secured the item in my locked evidence cabinet. Later that day, I removed Item #SL14 from my locked evidence cabinet. At 1447 hours, I released Item #SL14 to DOJ Property Controller E. Esser. Refer to BFS Case #RI-12-009029 and the attached Physical Evidence Submission Form.

On 10/23/12, I received a phone request from Det. Rick Cobb to pick-up the attached weapon light for Item #DL01: "GLOCK" model 22, .40 cal black handgun (serial # [REDACTED], with attached "XIPHOS NT" barrel light (Officer D. Lim #1605 weapon), and release the light to Officer D. Lim. At 1056 hours, I took possession of the weapon light from DOJ Office Technician T. Dukes-Robinson. I transported the weapon light to the Magnolia Station, and secured it in my locked evidence cabinet.

On 10/30/12, at 1028 hours, I released the weapon light to Officer Lim. No further action was taken.
