Narrative of Supplemental Report:

On 5-10-2011 at around 1800 hours I responded to a radio call of unknown trouble with possible shots fired. Upon arrival I assisted other officers with taking a suspect into custody in the driveway of 11531 Trailway Dr. I then assisted with securing other occupants of the 11531 Trailway Dr. I received identifying information of the subject inside 11531 Trailway Dr. and they were placed in the care of Detective Collopy prior to be transferred to the Magnolia Station by other officers. The subjects were W/Jeffery Stern, W/Ruth Stern, W/Kenneth Griffin, W/Marie Griffith and W/Smith.

I contacted W/Long and recorded her statement on my department digital recorder. W/Long told me the following: W/Long was in the front right passenger seat of a vehicle being driven westbound on Trailway Dr. W/Long saw a Police Officer exit his police vehicle and walk with a handgun drawn along the south side of Trailway Dr. westbound. W/Long saw an unknown subject standing flat against the side of a white box truck parked along the south curb of Trailway Dr. W/Long heard several gunshots and thought someone was shooting at the police officer. W/Long ducked down in the vehicle she was riding in and did not see who was shooting or the officer fire his weapon.

I talked with W/White who told me the following: W/White was inside her residence, 11539 Streampoint Court w/ is the street south of Trailway Dr. W/White heard gunshots and females screaming. W/White heard 4 to 5 more gunshots and the screaming stopped. W/White continued to hear gunshots after and called 911. W/White heard a total of 20 gunshots but did not see anything.
