As I approached I could see AMR personnel working on a M/B subject laying face down on the north sidewalk of Trailway Drive just east of 11531 Trailway Drive. Detective J. Wood and I were told to make our way the rear of 11531 Trailway Drive. We were to take up a containment position at the N/W (2/3) corner of 11531 Trailway Drive. We ran to the back and took up our position. We stayed in our position until the house was cleared by other officers.

I went back out to the middle of the street and was directed by Sgt. Corbett to go inside 11532 Trailway Drive. He requested I go inside and assist other officers with another search of the residence for possible victims. We completed the search without locating any other victims.

I checked the area for any other possible witnesses, but did not locate anyone. Officer Elliott and I stood by at the corner of Trailway Drive and Parkhill Way to keep people from entering the crime scene from the west side. At approx. 2300 hours we were released by other officers and left the scene.
