Supplemental Report

INVESTIGATING OFFICER

1 **Source of Activity:**

2 On Wednesday, November 16, 2011, Sgt. Dinco and I responded from the Fairmount station to the Hidden Springs  
3 apartments located at 10406 Indiana Avenue to assist with a call for help from SACA detectives. Detective L.  
4 Ellefson broadcasted over the radio, shots fired/11-99 (Officer needs help). Sgt. Dinco and I drove directly to the  
5 command post (CP), which was in front of the leasing office on Indiana Ave. A short time later the CP was moved  
6 into the large TV room inside the leasing office.

8 **Investigation:**

9 At the time of our arrival the suspect was barricaded inside his apartment. I assisted Sgt. Dinco with duties at the  
10 command post until the scene was secured. I was then assigned by Sgt. Dinco to canvass Building "L" for  
11 witnesses.  
12

13 I spoke to Alonso Barraza and his mother Graciela Barraza in Apt. [REDACTED] at 1107 hours. Graciela only spoke  
14 Spanish. Alonso told me the only other person who lives there is his father Alonso Barraza Sr., who also only  
15 speaks Spanish. Alonso Sr. was not home when I first got there. He arrived just before I left. Alonso Jr. told me  
16 he did not hear any of the commotion from this morning and did not witness any of it. I showed him a photo of S1  
17 and he said he did not know him and has never spoken to him before. Alonso Sr. and Graciela also looked at the  
18 photo and said they have seen S1 before but also did not know him. Neither of them heard this morning's incident  
19 and did not witness anything either. I recorded my conversation with the Barraza's on my digital audio recorder.
