Interview of John Hicks

During my interview with S-Bond's mother, O-Rivera, O-Hicks was in the house with other family members. After speaking to O-Rivera, I asked O-Hicks if I could speak to him outside. He agreed. I continued recording on my digital recorder from the interview with O-Rivera.

O-Hicks said that he is friends with S-Bond. He said he has known S-Bond since he was a kid.

O-Hicks said that he had not seen S-Bond for a few weeks, until he spoke to him two days ago. (Thursday) He said that S-Bond came over to hang out. He said that while he was there, they started talking about S-Bond's girlfriend. O-Hicks told me that S-Bond's girlfriend had climbed out of the window at S-Bond's house and ran to his house. He said she had black eyes and was bruised on her face. S-Bond told him that he was "interrogating" her for cheating on her.

O-Hicks said that S-Bond told him that he did not know why the cops were looking for him. He told me that he believed S-Bond did know why the cops were looking for him. S-Bond told him that he would take a bullet before he went back to jail. He said he knew S-Bond had a 45 Automatic handgun. He said he did not see S-Bond with the gun, but knew he had one.

When I was concluding my interview with him, O-Hicks said that he would never "fuck" with S-Bond. He said he was a "Bad mother-fucker".

The interview was concluded.
