

GRANT DEED

FOR VALUABLE CONSIDERATION, receipt of which is hereby acknowledged, the CITY OF RIVERSIDE, a municipal corporation, does hereby grant to STATER BROS. MARKETS, a California corporation, the real property in the City of Riverside, County of Riverside, State of California, described as follows:

Parcel 2 of Record of Survey, as shown by map on file in Book 54, Page 7 of Record of Surveys, records of Riverside County, California;

EXCEPTING THEREFROM the northwesterly 4.00 feet.

Area - 0.4648 acres.

An easement for unobstructed right of vehicular and pedestrian access to pass over and across a strip of land 25 feet in width, more particularly described as follows:

That portion of Lot 1 in Block 66 of Arlington Heights, as shown by map on file in Book 11, Pages 20 and 21 of Maps, records of San Bernardino County, California, described as follows:

COMMENCING at the intersection of the centerline of Mary Street (variable width), with the centerline of Lincoln Avenue (80 feet wide), as said streets are shown by map of Royal Groves No. 3, on file in Book 32, Page 100 of Maps, records of Riverside County, California;

THENCE North 56° 02' 28" East, along the centerline of Lincoln Avenue, 410.10 feet;

THENCE South 33° 57' 32" East, 40.00 feet to the most westerly corner of Lot 96 of said map of Royal Groves No. 3;

THENCE South 56° 02' 28" West, along the southeasterly right-of-way line of Lincoln Avenue, said line also being the northwesterly line of said Lot 1, a distance of 21.25 feet to the true POINT OF BEGINNING:

THENCE South 33° 57' 32" East, 110.00 feet;

THENCE South 56° 02' 28" West, along a line which is parallel to the northwesterly line of said Lot 1, a distance of 25.00 feet;

THENCE North 33° 57' 32" West, 110.00 feet to a point in the northwesterly line of said Lot 1;

THENCE North 56° 02' 28" East, along the northwesterly line of said Lot 1, 25.00 feet to said true POINT OF BEGINNING.
