Permittee acknowledges that the described property is dedicated and acquired for the future proposed widening and improvement of Fourteenth Street in the Gity of Riverside, and that accordingly, all rights and privileges of use and possession shall cease on the date of the award of the contract for the widening and improvement of Fourteenth Street, including the described location. Upon expiration or revocation of this permit, it is provided the Permittee shall remove the improvements at their expense. In the event the Fermittee fails to remove the improvements when requested, the Gity shall have the right to remove and destroy the improvements without reimbursement to Permittee.
