A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, DEDICATING AND ACCEPTING CERTAIN LANDS OWNED BY THE CITY AS PART OF THE FORMER MULBERRY YARD FOR PUBLIC STREET PURPOSES TO BECOME AND BE KNOWN AS PORTIONS OF NINTH STREET, VINE STREET AND MARKETPLACE WAY.

WHEREAS the Redevelopment Agency of the City of Riverside, California ("Agency") is undertaking the implementation of the Redevelopment Plan for the Riverside Central Industrial Redevelopment Project; and

WHEREAS the City of Riverside ("City") holds title to that certain real property commonly known as the Mulberry Yard located within the Riverside Central Industrial Redevelopment Project Area; and

WHEREAS on September 17, 1991, the City of Riverside ("City") and the Agency entered into a Cooperative Agreement wherein the City agreed to convey fee simple title to the Mulberry Yard to the Agency; and

WHEREAS the Agency will subsequently convey the title to the Mulberry Yard to Birtcher Campbell Properties ("Developer") pursuant to an Owner Participation Agreement dated January 5, 1990; and

WHEREAS prior to executing the deed conveying the Mulberry Yard to the Agency it is necessary for the City to dedicate and accept certain street right-of-way required for Ninth Street, Vine Street and Marketplace Way; and

WHEREAS the dedication is necessary to accommodate off-site improvements being constructed by the Developer;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside, California, as follows:

Section 1: That the strip or parcel of land located in the City of Riverside, County of Riverside, State of California, described as "Parcel A" on Attachment 1, attached hereto and incorporated herein by this reference, is hereby dedicated by the City of Riverside for public use for street purposes to become and be known as a portion of Ninth Street, and is hereby accepted by said City of Riverside for such purposes.

Section 2: That the strips or parcels of land located in the City of Riverside, County of Riverside, State of California, described as "Parcel B" on Attachment 2, attached hereto and incorporated herein by this reference, are hereby dedicated by the City of Riverside for public use for street purposes to become and be known as a portion of Ninth Street, and are hereby accepted by said City of Riverside for such purposes.

Section 3: That the strip or parcel of land located in the City of Riverside, County of Riverside, State of California, described as "Parcel C" on Attachment 3, attached hereto and incorporated herein by this reference, is hereby dedicated by the City of Riverside for public use for street purposes to become and be known as a portion of Vine Street, and is hereby accepted by said City of Riverside for such purposes.

Section 4: That the strip or parcel of land located in the City of Riverside, County of Riverside, State of California, described as "Parcel D" on Attachment 4, attached hereto and

incorporated herein by this reference, is hereby dedicated by the City of Riverside for public use for street purposes to become and be known as a portion of Marketplace Way, and is hereby accepted by said City of Riverside for such purposes.

Section 5: That the strip or parcel of land located in the City of Riverside, County of Riverside, State of California, described as "Parcel E" on Attachment 5, attached hereto and incorporated herein by this reference, is hereby dedicated by the City of Riverside for public use for street purposes to become and be known as a portion of Vine Street, and is hereby accepted by said City of Riverside for such purposes.

Section 6: The dedication and acceptance of the above-described strips or parcels of land for public use for street purposes shall include and does hereby include all rights to construct and maintain utilities, sewers, drains and other improvements consistent with the use as a public street.

Section 7: The City Clerk of the City of Riverside is authorized and directed to cause a certified copy of this resolution to be recorded in the office of the County Recorder of Riverside County, California.
