Thence North 89° 55' East, a distance of 60.00 feet to a point in the west line of that certain parcel of land conveyed to Clarence 0. Willcut et ux, by deed recorded in Book 738 of Official Records of Riverside County, California, at Page 269 thereof;

Thence South 00° 05' East along said west line, a distance of 200.00 feet to a point thereon for the TRUE POINT OF BEGINNING;


