A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RIVERSIDE, CALIFORNIA, ACCEPTING FOR PUBLIC STREET PURPOSES AS PART OF MOUNTAIN AVENUE A FIFTEEN FOOT WIDE STRIP OF LAND EXTENDING FROM LA SIERRA AVENUE TO A POINT APPROXIMATELY 327.68 FEET SOUTHWESTERLY THEREOF.

WHEREAS the public for many years has used a portion of land hereinafter described and known as Mountain Avenue as a public street; and

WHEREAS said property has been maintained by the City cf Riverside as a public street since annexation of said property to said City and by the County of Riverside prior to such annexation; and

WHEREAS said hereinafter described property has been used as ingress to and egress from La Sierra Avenue for those property owners abutting upon the property known as Mountain Avenue; and

WHEREAS the fee owner of said property has offered same to the City of Riverside for street purposes;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Riverside as follows:

Section 1: The public convenience and necessity demand the acceptance of the offer of dedication, and the maintenance of, a fifteen foot wide strip of land known as Mountain Avenue extending from La Sierra Avenue to a point approximately 327.68 feet southwesterly thereof.

Section 2: The hereinafter described parcels of land located in the City of Riverside, County of Riverside, State of California, and conveyed to the City of Riverside in fee, be and are hereby accepted for public use for street purposes as a portion of Mountain Avenue:

PARCEL A

That portion of Lot 5 in Block 60 of Tract No. 2 of LA SIERRA HEIGHTS, on file in Book 7 of Maps at Page 66 thereof, records of said Riverside County, described as follows:

BEGINNING at the most easterly corner of said

Lot;

THENCE Southwesterly along the southeasterly

line of said Lot a distance of 50 feet;

THENCE Northwesterly parallel with the northeasterly line of said Lot a distance of 15 feet;

THENCE Northeasterly parallel with said southeasterly line 50 feet to said northeasterly line;

THENCE Southeasterly along said northeasterly
line 15 feet to the point of beginning.

PARCEL B

That portion of Lot 5 in Block 60 of Tract No. 2
of LA SIERRA HEIGHTS, on file in Book 7 of Maps, at
Page 66 thereof, records of said Riverside County,
more particularly described as follows:
BEGINNING at the most easterly corner of said Lot;
THENCE South 62° 02'. 30" West, along the southeasterly line of said Lot a distance of 277.68 feet;
THENCE North 27° 04' West, parallel with the northeasterly line of said Lot a distance of 15.00 feet;
THENCE North 62° 02' 30" East 277.68 feet to said
northeasterly line of said Lot;
THENCE South 27° 04' East, along said northeasterly
line 15.00 feet to the point of beginning.

Section 3: The City Clerk of the City of Riverside is authorized and directed to cause a certified copy of this resolution to be recorded in the office of the County Recorder of Riverside County, California.
