

OFFER OF DEDICATION

On this	il TH day of October, 1980,

irrevocably offer for dedication to the CITY OF RIVERSIDE, a municipal corporation, pursuant to the provisions of California Government Code Section 7050, for public street and highway purposes, together with all rights to construct and maintain utilities, sewers, drains and other improvements consistent with the use as a public street and highway, that real property located in the City of Riverside, County of Riverside, State of California, and more particularly described as follows:

That portion of Lot 8, in Block 74 of La Sierra Heights Tract No. 2 as shown by map on file in Book 7 of Maps, at Page 66 thereof records of Riverside County, California, described as follows:

BEGINNING at a point in the northeasterly line of said Lot 8, bearing North 12° 05' 00" West, a distance of 147.21 feet northwesterly of the southeasterly corner of said Lot; said northeasterly line also being the westerly line of that certain parcel of land conveyed to Robert J. Scott et ux, by deed recorded September 1, 1977 as Instrument No. 171762 of Official Records of Riverside County, California;

THENCE South 71° 07' 00" West, parallel with the southeasterly line of said Lot 8, a distance of 238.37 feet;

THENCE North 55° 42' 06" West, a distance of 19.96 feet to a point in a line which is parallel with and distant 43.00 feet northeasterly as measured at right angle, from the southwesterly line of that certain parcel of land conveyed to Gene R. Fiset et ux, by deed recorded July 22, 1977 as Instrument No. 139909 of Official Records of Riverside County, California;

THENCE North $14^{\rm O}$ 13' 00" West, along said parallel line a distance of 311.21 feet;

THENCE North 24° 58' 25" East, a distance of 29.63 feet to a line which is parallel with, and distant 14.00 feet southeasterly as measured at right angle from the southeasterly line of Lot C (Cypress Avenue), as shown by said map;
