PEX piping that has not been previously Approved by the City must undergo a review and acceptance process which is initiated by the product manufacturer. The most recently updated list of Approved PEX piping systems is attached.

We, the undersigned, request that the City authorize the use of City Approved PEX water piping as an alternate method and material in the above noted project, and do hereby agree as follows:

1. These products shall be installed in accordance with the manufacturer's installation instructions, which will be available at the job site for use by the Building Inspector, upon request.
2. All installers of the product will be properly trained and certified by the manufacturer. Proof of such may be required by the Building Inspector.
3. A plumbing isometric drawing and pipe sizing calculations may be required by the Building Inspector prior to inspection approval. The Building Official reserves the right to require said plans to be stamped and signed by a licensed professional engineer knowledgeable in potable water piping systems.

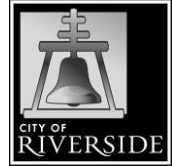
