Four signatures are required for each dollar of filing fee.  Within 10 days after receipt of a petition, the City Clerk shall notify the candidate of any deficiency. The City Clerk shall consolidate the notice of election and the notice of measure to be voted on into one notice if the measure was placed on the ballot before the notice of election is published.</p>
