COMMUNITY POLICE REVIEW COMMISSION

City of Riverside

November 16, 2000, 6 p.m.

City Council Chamber

Present: Brewer, Hendrick, Gardner, Redsecker, Huerta, Egson, Howe, and Garcia

Absent: Goldware

Executive Director Don Williams called the meeting to order at 6 p.m.

Commissioner Garcia entered during the following discussion.

SELECTION OF 2-, 3-, AND 4-YEAR TERMS

Selection by lottery was held to determine the commissioners to serve 2-, 3-, and 4-year terms. Commissioners Gardner, Egson, and Goldware were selected for 2-year terms; Commissioners Redsecker, Hendrick, and Garcia were selected for 3-year terms; and Commissioners Huerta, Brewer, and Howe were selected for 4-year terms.

SELECTION OF INTERIM CHAIRPERSON AND VICE-CHAIRPERSON

Selection by lottery was held to determine the interim chairperson and vice-chairperson. Commissioner Garcia was selected as the interim chairperson and Commissioner Gardner was selected as the interim vice-chairperson.

PUBLIC COMMENTS

Mary Shelton spoke regarding the Internal Affairs Division of the Police Department. Pete Bollinger and Doug Leeper spoke regarding their appreciation of the Police Department.

BROWN ACT TRAINING

Deputy City Attorney Eileen Teichert gave a short presentation regarding the Brown Act and answered the Commissioner's questions.

MEETING SCHEDULE

Following discussion relative to the day and time for the regularly scheduled monthly meetings of the Commission, motion was made by Commissioner Huerta and seconded by Commissioner Howe recommending the regularly scheduled meetings of the Commission be held the second Thursdays of each month at 6 p.m. Following further discussion, a substitute motion was made by Commissioner Egson and seconded by Commissioner Howe recommending the regularly scheduled meetings of the Commission be held the fourth Mondays of each month at 6 p.m. in the Council Chamber. The substitute motion carried unanimously.

Motion was made by Commissioner Gardner and seconded by Commissioner Howe to discuss the two items regarding the Rules and Regulations of the Commission as one item. Motion carried seven to one with Commissioner Redsecker voting no.

RULES AND REGULATIONS

Following discussion relative to the Rules and Regulations of the Commission, motion was made by Commissioner Brewer and seconded by Commissioner Garcia to (1) establish a subcommittee consisting of three Commissioners to discuss the general Rules and Regulations of the Commission excluding the Investigative Hearing; and (2) establish a subcommittee consisting of three Commissioners to discuss the Rules and Regulations of the Investigative Hearing. Motion carried unanimously.

Following discussion relative to which Commissioners will serve on the subcommittees, Commissioners Hendrick, Huerta, and Garcia volunteered to serve on the general Rules and Regulations subcommittee and Commissioners Howe, Brewer, and Egson volunteered to serve on the Rules and Regulations of the Investigative Hearing subcommittee. Motion was made by Commissioner Gardner and seconded by Commissioner Garcia to approve the members of the subcommittees as stated above. Motion carried unanimously.

TRAINING SCHEDULE

Following discussion, and without formal motion, the Commission indicated future training sessions should be held in the evenings.

The Commission adjourned at 7:10 p.m.
