On Monday 9-1-08 at approximately 2017 hours I was working uniformed patrol as C110 in vehicle 3762 when I heard Ofc Munoz advise "shots fired" over the radio. I put myself enroute to his call via my MDC and immediately began responding to his location. I arrived in the area of Yarborough Dr and Dole Ct about ten minutes later. Once onscene, I learned that an officer involved shooting had just occurred and I assisted the [Redacted]

Once the location was secured, I learned that W/Thomas Martin Castro ([Redacted]) had been detained and placed in my patrol car. I transported him to the Magnolia police station at Lt. Hurt's direction. I remained with him and several other witnesses until Sgt Blomdahl asked me to return to the scene and relieve Ofc Hicks as the Crime Scene Log recorder. I relieved Ofc Hicks at approximately 0105 hours and remained at the scene until approximately 0555 hours when the crime scene was broken down and everyone cleared.
