On 9/03/08, at approx 0730 hrs, I was assigned to document the autopsy of Quinonez, Carlos David DOB [REDACTED] to be done on 9/04/08 at the Riverside County Sheriff-Coroner's Morgue.

On 9/04/08, I arrived at the Riverside County Sheriff-Coroner's Morgue at 0840 hrs. Attending the autopsy were Forensic Pathologist Fajardo, Forensic Technician G. Wilson [REDACTED] and Coroner Technician A. Maldonado [REDACTED] Detective G. Rowe, Riverside City Attorneys G. Priamos and J. Brown, Sergeant M. Smail and Police Property Specialist Kellie Duncan viewed the autopsy from the observation room.

The autopsy began at 0930 hrs. I took a total of (136) digital photographs of the post examination. (See attached Photo Log) The autopsy concluded at 1146 hrs. I took possession of and retained (14) evidence items from Forensic Technician G. Wilson that I marked as Evidence Items SLR-01 thru SLR-14. (See Property Reports)

I cleared the location at 1240 hrs and responded to the RPD Magnolia St. Station. I downloaded the (136) digital photographs to a secure file format in the RPD Evidence Unit Computer Photo Lab at 1338 hrs.

I transported and released Evidence Items SLR-05 thru SLR-14 to Police Program Supervisor Anne Sansky at the RPD Property Unit. I secured Evidence Items SLR-01 thru SLR-04 in the Evidence Unit.

On 9/05/08, at 1432 hrs, I transported and released Evidence Items SLR-01 thru SLR-04 to the RPD Property Unit via Biohazard locker #3.

On 9/08/08, at 0925 hrs, I received (1) CD copy of the X-Rays of: Quinonez, Carlos David DOB [REDACTED] taken at the Riverside County Sheriff-Coroner's Morgue. I labeled the (1) CD as Evidence Item SLR-15.

On 9/10/08, at 1307 hrs, I transported and released Evidence Item SLR-15 to Police Property Specialist Noreena Jaggar at the RPD Property Unit.
