1 **Narrative:**

2
3 On Tuesday, 05-11-11, at about 1757 hours I responded to assist officers in the area of 11532 Trailway
4 Dr. reference shots being fired while Officer Fishell was on scene at an unknown trouble call. I arrived
5 and found officers at the location with one subject down to the front of 11531 Trailway Dr.

7 While Officers safely cleared 11532 Trailway Dr., I held a perimeter position to the front of 11531
8 Trailway Dr. Once 11532 Trailway Dr was cleared, I assisted in conducting a safety sweep of the interior
9 of 11531 Trailway Dr. No other subjects were located inside the residence.

10
11 Once the scene was secured I canvassed the area where Officer Fishell possibly fired his department
12 issued weapon from. In the front lawn of 11514 Trailway Dr., I located an expended casing similar to one
13 issued to officers by the department (40 caliber). I remained at the location where the casing was found
14 until I was later relieved.

15
16 While waiting for evidence technicians to respond, I made contact with the resident of the home and
17 asked him if he at seen or heard anything that had happened: O/Chu said he works from home and was
18 inside on the phone. He heard what he at first thought to be about 8-10 gunshots. He was not sure if it
19 was gunfire so he opted not to look out of the window. He was unaware that anyone had been shot or
20 injured.

22 I held my scene security/evidence protection position until I was later released from the scene by Sgt.
23 Corbett at about 2300 hours.
