On the Above listed date and time partner Officer T. Jensen and I responded to the above listed address to assist after "Shots fired" was announced over the radio. Upon arrival we learned that the suspect was injured and medical aid was on scene. Medical aid treated the suspect while we insured no evidence was disturbed. After medical aid left, the scene was secured and we contacted any possible witnesses.

I contacted O/Hurtado who lives at [Redacted] O/Hurtado told me that he was in his drive way working on his truck when he heard approximately seven gunshots. O/Hurtado heard a noise which he described a "Ping" on the west side of his house. O/Hurtado went inside his residence, and shortly after heard females screaming. We inspected the west wall and the [Redacted] between O/Hurtado's house and the above listed address but we were unable find anything unusual.
