Narrative of Supplemental Report:

On 02/23/12 at approximately 1330 hours, I was requested by Detective D. Smith to collect possible blood swabs from evidence item ME-09: Colt 45 M1991A1 Series hand gun and then transport evidence items ME-09 and ME-9B: (1) magazine and (6) Federal 45 auto cartridges to the Department of Justice (DOJ) Riverside Criminalistics Laboratory for analysis. I received evidence items ME-09, ME-9A: (1) Federal 45 auto cartridge from chamber and ME-9B from Senior Forensic Technician T. Ellis at 1330 hours and placed them into my secured evidence locker.

On 02/28/12 at approximately 1115 hours, I retrieved evidence item ME-09 from my secured evidence locker for processing. I collected (2) possible blood swabs & (1) reagent swab and labeled them evidence item ME-09A (see attached Evidence Log and/ or Property Report). I finished my assignment and placed evidence item ME-09 back into my secured evidence locker. I finished processing evidence item ME-09A and placed it into the Magnolia Station Evidence Locker #43 at approximately 1245 hours.

On 02/29/12 at approximately 0810, I retrieved evidence items ME-09, ME-9A and ME-9B from my secured evidence locker and released them to Police Property Specialist N. Jaggar at approximately 0812 hours. I then received evidence items ME-09 and ME-9B back from Jaggar and transported them to (DOJ). I arrived at the location and released both evidence items to Laboratory Technician C. Larsen at approximately 0952 hours (see attached BFS Submission Form RI-12-1659). I finished my assignment and left the location.
