Prior to arrival Ofc. Garcia advised the subject (S1) was last seen wearing a black shirt, tan shorts, and may have gone into the Chevron Gas Station located at 3476 Van Buren. Upon arrival we parked our patrol unit on the westside of Van Buren just north of the Chevron Gas Station. Ofc. Barnhill and I met up with Sgt. Tiptre and waited for assisting officers. While waiting for assisting Officers dispatch had both store employees exit the building. The employees walked back to our location and one of them advised he had seen an unknown subject go behind the building. Along with assisting Officers we approached the northwest corner of the building. As we rounded the northwest corner of the building we located S1 who was standing facing west near the southwest corner. Sgt. Tiptre told S1 several times to show us his hands. hands above him but then began moving toward the southwest corner of the building. As S1 was moving toward the southwest corner his hands went back down and he disappeared out of view around the southwest corner. I broadcasted to assisting officers that S1 was moving south. I then heard numerous gunshots and ran toward the eastside of the building where I saw S1 laying on his stomach near the southwest corner of the parking lot. Both of S1's hands were out of my view and assisting officers advised he was holding a gun. Along with assisting officers I assisted in placing handcuffs on S1. I noticed a revolver on the ground where S1's left hand had been. We moved S1 away from the revolver and placed him on the ground a safe distance from it.

I then assisted with securing the scene. We cleared the scene at 0350 hours.
